BECAUSE OF THE GLOBAL PANDEMIC, THE 6TH SAMUEL BELZBERG INTERNATIONAL DYSTONIA SYMPOSIUM WAS RESCHEDULED FROM JUNE 2020 TO JUNE 2023. THE RESCHEDULING HAS BEEN MANAGED BY THE DMRF AND PLANNING FOR THE 2023 PROGRAM CONTINUES.

THE DMRF HOSTED A VIRTUAL SCIENTIFIC MEETING ENTITLED "DEFINING THE ROLE OF BRAIN NETWORKS IN THE PATHOPHYSIOLOGY AND TREATMENT OF DYSTONIA". BY GATHERING TOGETHER A SELECT GROUP OF RESEARCHERS EXPLORING THIS IMPORTANT ISSUE, THE DMRF HOPES TO ESTABLISH CONNECTIONS BETWEEN GREAT SCIENTIFIC MINDS TO BETTER UNDERSTAND THE MECHANISMS OF DYSTONIA.
